FINDING OF NO SIGNIFICANT IMPACT

The City of Muskegon Heights has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at the Department of Planning and Community Development, City Hall, 2724 Peck St, Muskegon Heights, MI, 49444 and may be examined weekdays from 8:30 A.M. to 5:00 P.M. or online at cityofmuskegonheights.org. The FONSI and RROF has been posted on the City's website commencing May 15, 2019.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the Department of Planning and Community Development. All comments received by June 1, 2019 will be considered by the City of Muskegon Heights prior to authorizing submission of a request for release of funds. Comments should specify which Notice is being addressed. The Public Hearing has been set for Monday, May 13, 2019, in the City Hall (Council Chambers) at 5:30 p.m. To make comments a part of the ERR, comments must be provided in writing.

RELEASE OF FUNDS

The City of Muskegon Heights certifies to HUD that the Mayor in the official capacity consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce the responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. The U.S. Department of Housing and Urban Development's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of Muskegon Heights to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the City of Muskegon Heights' certification for a period of fifteen (15) days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Muskegon Heights; (b) the City of Muskegon Heights has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR part 58, Sec. 58.76) and shall be addressed to the Environmental Officer, U.S. Department of Housing and Urban Development - Detroit Field Office, Patrick V. McNamara Federal Building - 477 Michigan Ave. Room 1710, Detroit, MI 48226-2592. Potential objectors should contact HUD Environmental Officer, HUD Detroit Field Office (tel. 313-226-7900 or via fax 313-226-5611) to verify the actual last day of the objection period.
