EFFECTIVE FEBRUARY 1, 2020, ALL <u>NEW RENTAL REGISTRATIONS</u> ARE DUE ANNUALLY IN THE AMOUNT OF \$75.00.

FAILURE TO RENEW BY MARCH 5<sup>TH</sup> OF EACH YEAR WILL RESULT IN A MUNICIPAL CIVIL INFRACTION IN THE AMOUNT OF \$250.00. FURTHERMORE, A \$100.00 PENALTY WILL BE APPLIED TO THE REGISTRATION RENEWAL APPLICATION.

ANY PRORATE CREDITS FOR RENEWAL ANNIVERSARY DATES THAT FALL AFTER FEBRUARY 1, 2020, WILL BE **APPLIED TO THE FEBRUARY 1, 2021** RENEWAL APPLICATION (SEE BOTTOM FOR INFORMATION ON CALCULATING YOUR CREDIT AGAINST YOUR 2021 RENEWAL APPLICATION).
