## 1. RECEIPT OF BIDS

Sealed bids for the above project will be received by City of Muskegon Heights of 2724 Peck Street, Muskegon Heights, Michigan until:

**2:00 P.M. (local time) on Tuesday, May 31, 2022**

at which time the bids will be publicly opened and read aloud.

## 2. SCOPE OF PROJECT

The project consists of furnishing all material and constructing the following approximate quantities:

- 5,760 ft. of 4-inch to 18-inch water main
- 106 full water service replacements
- 1,000 ft. of 12-inch storm sewer
- 4,500 ft. of road reconstruction

Including all necessary appurtenances and restoration.

Hard copy drawings (\$72.00) and specifications (\$85.00) are available for the fee of \$157.00 dollars. A \$15 dollar charge will be added to all mailed drawings and/or specifications. Fees are payable by cash or check only and are not refunded.

5. DISADVANTAGED BUSINESS ENTERPRISES (DBE)

The Prime Contractor is hereby notified that their bidding on this project must follow, document, and maintain documentation of their Good Faith Efforts to ensure that DBEs have the opportunity to participate in the project by increasing DBE awareness of procurement efforts and outreach.

Posting solicitations for quotes/proposals from DBEs on the Michigan Infrastructure and Transportation Association (MITA) website in accordance with conditions detailed in Exhibit 1 is recommended ([www.mitadbe.com](http://www.mitadbe.com)).

6. FUNDING

The work to be performed under this contract will be financed and paid for by funds received from by the Michigan Department of Environment, Great Lakes, and Energy (EGLE) Drinking Water Revolving Fund (DWRF) and with City of Muskegon Heights local funds. DWRF monies will be received by the City of Muskegon Heights. **Davis-Bacon/Prevailing Federal Wages apply to this project.**

Federal Labor Standards Provisions and associated documents that are incorporated in this contract are included in Appendix A. The DWRF Project Number is 7575-01 and 7576-01.

The Contractor also will be required to comply with the debarment and American Iron and Steel contractual language included in Appendix A.

7. BID SURETY

A bid bond, certified check, or cashier's check payable to City of Muskegon in an amount equal to five percent (5%) of the total price shall accompany each bid. This surety shall bind the bidder for a period of one hundred twenty (120) days after the receipt of bids.

8. COMPLETION DATE

All work shall be substantially completed (Roads open to traffic) on November 2, 2023. Final restoration and project completion shall occur on or before November 17, 2023. See agreement for specific milestone requirements.
